FOR PROFESSIONAL SERVICE TO SUPPLY PANELS INTRODUCING VIETNAM FARMERS' UNION HOTLINE 18001768 SUPPORTING WOMEN AND GIRLS SUBJECTED TO VIOLENCE

1. BACKGROUND

Typhoon Yagi, the strongest storm to hit Viet Nam in 30 years, struck the northern region on 7 September 2024, bringing devastating floods and landslides. The storm displaced over 130,000 people, damaged more than 240,000 homes, and severely disrupted essential services, including health, social support, and protection mechanisms. Among the most affected provinces, Lao Cai and Cao Bang experienced large-scale flooding, landslides, and destruction of critical infrastructure, significantly heightening vulnerabilities for women and girls.

In emergency situations, the risk of gender-based violence (GBV) escalates due to displacement, economic stress, and breakdown of protection systems. Overcrowded and under-resourced evacuation centers pose additional risks, particularly for women and children, who are more vulnerable to violence, exploitation, and abuse. The disruption of communication systems and support services has made it more difficult for GBV survivors to seek help or access critical assistance, leaving many at heightened risk of harm.

Before the disaster, Viet Nam already faced significant GBV challenges. According to the 2019 National Study on Violence Against Women, 62.9% of ever-married women aged 15-64 reported experiencing some form of violence by an intimate partner, yet 90.4% never sought help from formal service providers². The lack of accessible GBV services was one of the primary barriers preventing survivors from reporting abuse or seeking support. The impact of Typhoon Yagi has exacerbated this issue, worsened isolation and limited access to available resources, especially for women in remote, rural, and disaster-affected areas.

To address this urgent need, UNFPA, with funding from the Australian Department of Foreign Affairs and Trade (DFAT), is collaborating with the Vietnam Farmers' Union (VFU) to expand the visibility and reach of the GBV hotline 1800 1768 in Lao Cai and Cao Bang. This toll-free 24/7 hotline, established in December 2021 under a UNFPA-supported project, provides confidential, survivor-centered counseling and referral services. Despite its proven effectiveness—having handled over 17,600 calls and assisted 2,750 GBV survivors as of January 2025—many women and girls in affected areas remain unaware of this life-saving service.

To bridge this information gap, UNFPA and VFU will distribute 3,400 communications panels across Lao Cai and Cao Bang to ensure wider awareness and accessibility of the hotline. By increasing visibility in high-risk communities, this initiative aims to enhance survivors' access to timely and appropriate GBV response services, ensuring that no woman or girl facing violence is left without support—even in the aftermath of disaster.

2. PURPOSE/OBJECTIVES

The main objective of the professional service is to disseminate information on the hotline number 1800 1768 providing free counselling service for GBV survivors in Lao Cai and Cao Bang provinces.

3. SCOPE AND FOCUS

- To print panels with following specifications:
 - Quantity: **3,400 panels**
 - Dimension: H1m x W1.2m
 - Specification: Iron-box frame galvanized x20, Hiflex canvas printed according to provided design, lined with flower corrugated iron. V20 aluminium bezel (*Khung sắt hộp mạ kẽm x20, mặt bạt Hiflex in theo thiết kế, lót tôn hoa. Viền kẽm nhôm V20*).
 - Content: panels will be designed in Vietnamese and the most widely used local ethnic languages in Cao Bang and Lao Cai (the specific languages will be identified after the selection of the service provider). Kindly refer to the attached image illustration in Annex 1 for reference.
- After printing, deliver 3.400 panels to the offices of Commune Farmers' Union. The Commune Farmers' Union will be responsible for hanging these panels in Lao Cai and Cao Bang provinces.
- Tentative implementing time: from 10 May – 10 June 2025

4. FINAL PRODUCTS/DELIVERABLES

The final product is:

- 3,400 panels approved by UNFPA to be delivered to the offices of Commune Farmers' Union in Lao Cai and Cao Bang provinces together with photos serving as evidence for receipt.

5. INTENDED USES & USERS

5.1 Intended uses:

- To circulate information about available free of charge supporting services through the hotline 1800 1768

5.2 Intended users:

- General population, especially women and girls who are experiencing and/or at risk of gender-based and domestic violence

6. APPROACH AND METHODOLOGY

- The assignment will be conducted in a way that is gender and human-rights-responsive, inclusive, victim-centered approach.
- Interested service providers will submit a quotation for the services, a concrete implementation timeline.

7. ACCOUNTABILITIES

7.1 The selected service provider will:

- Be technically and contractually accountable to the UNFPA Country Office for all aspects of the assignment;
- Be responsible to complete and abide by all local regulations and procedures for permission to produce 3,400 panels;

- Deliver the tasks expressed in this TOR in close consultation and collaboration with the assigned officers from UNFPA and with Commune Farmers' Union Offices;
- Consult and agree with UNFPA on the detailed plan and obtain UNFPA approval when required;
- Brief UNFPA on the progress of activity implementation against the planned timeframe;
- Consult UNFPA to address challenges and problems arising during the service provision; and
- Be responsible for the quality of the activities, and final products.

7.2 UNFPA Country Office (CO) will:

- Develop a contract for signing between UNFPA and the selected service provider; and
- Facilitate the selected entity in completing its assignment, including problem solving as mentioned in the TOR;
- Provide comments on the products including detailed work plan, activities implementation plan, and final report before they are finalized;
- Monitor the progress and quality of the activity's implementation.

7.3 Vietnam Farmers' Union will:

- Provide the design of panels;
- The consent forms for using models' image in the communication products
- Direct Commune Farmers' Union to hang panels on the wall outside the People's Committee of communes and wards, and the Provincial Farmers' Union;
- Support UNFPA to monitor the progress and quality of the activity's implementation, including spot-check of panel installment.
