TERMS OF REFERENCE

FOR PROFESSIONAL SERVICE TO SUPPLY PANOS INTRODUCING VIETNAM FARMERS' UNION HOTLINE 18001768 SUPPORTING WOMEN AND GIRLS SUBJECT TO VIOLENCE

1. BACKGROUND

Violence against women (VAW) is a manifestation of a pervasive human rights violation and happens in all countries, including Viet Nam. According to the UNFPA-supported National study on VAW in 2019, about 62.9% of ever-married women aged 15-64 reported that they had experienced some form of violence at least once in their lifetime by their husbands or intimate partners, while 50% of them did not talk with anyone about their violence experience, and 90.4% of them never sought help from formal service providers or the authorities. Among all of the reasons that gender-based violence (GBV) survivors did not seek help is the lack of accessible supporting services.

In this context, the hotline – 1800 1768 has been established by the Vietnam Farmers' Union (VFU) on 15 December 2021 with technical and financial support from UNFPA under the framework of the UNFPA project entitled "Mitigating COVID-19 impacts on Vulnerable Populations – Ensuring National Progress to Achieve SDGs in Viet Nam," which is funded by the Government of Japan. Since May 2022, the operational costs have thereafter been covered through UNFPA-supported project to the Viet Nam Farmers' Union "Prevention, control, and response to gender-based violence and other harmful practices in the 2022 - 2026 period" (code: VNM10P05) under the UNFPA Country Programme Document for Vietnam (CPD10) endorsed by the Prime Minister.

Through the toll-free hotline 1800 1768, counselling and support as well as referral services are provided 24/7, meeting international standards to ensure the rights and safety of survivors of violence. The establishment of the hotline is significant as supplementary, timely and friendly assistance is available and accessible to survivors of violence, especially those living in the rural areas. Up to March 2023, the hotline received more than 11,300 calls and provided consultation and support to nearly 1,400 women and girls suffering from gender-based and domestic violence, which highlight the high demand in supporting GBV survivors.

Among communication strategies to widely introduce the hotline 1800 1768, in early 2022, VFU printed nearly 2.000 panos and placed them at Ba Ria Vung Tau, Bac Giang, Hai Duong, Ho Chi Minh City, Da Nang City, Thanh Hoa, Thai Binh. This helped reach out to numerous local people, particularly women and girls who are experiencing and/or at risk of gender-based and domestic violence. With this undertaking, the number of calls have been increasing in the aforementioned provinces as summarised in the above paragraph. In order to continue to improve the accessibility of supporting services provided by the hotline to wider public, it is crucial to circulate information about the hotline via distributing related communication products to more cities and provinces. In this regard, the UNFPA Country Office wishes to engage an entity on a professional service contract to print, deliver 1.454 panos which introduces the hotline 1800 1768 in provinces listed in Annex 2 of this TOR.

2. PURPOSE/OBJECTIVES

The main objective of the professional service is to disseminate information on the hotline number 1800 1768 providing free counselling service for GBV survivors nation-wide.

3. SCOPE AND FOCUS

- To print pano with these specifications:
 - o Quantity: 1.454 panos
 - o Dimension: H1m x W1.2m
 - Specification: Iron-box frame galvanized x20, Hiflex canvas printed according to provided design, lined with flower corrugated iron. V20 aluminium bezel (Khung sắt hôp ma kẽmx20, mặt bat Hiflex in theo thiết kế, lót tôn hoa. Viền ke nhôm V20).
 - o Content: Kindly refer to attached image illustration in Annex 1 for reference.
- After printing, deliver 1.454 panos to the offices of District/Commune Farmers' Union. The District/Commune Farmers' Union will responsible for hanging these panos. See the list of provinces/districts/communes in Annex 2 for reference.
- Tentative implementing time: from 1 August 15 September 2023

4. FINAL PRODUCTS/DELIVERABLES

The final product is:

• The availability of 1.454 panos to be delivered to the offices of District/Commune Farmers' Union that were mentioned in the Annex 2, together with photos serving as evidence for receipt.

6. INTENDED USES & USERS

6.1 Intended uses:

• To circulate information about available free of charge supporting services through the hotline 1800 1768.

6.2 Intended users:

 General population, especially women and girls who are experiencing and/or at risk of gender-based and domestic violence,

7. APPROACH AND METHODOLOGY

- The assignment will be conducted in a way that is gender and human-rights-responsive, inclusive, victim-centered approach.
- Interested service provider will submit a quotation for the services, a concrete implementation timeline.

8. ACCOUNTABILITIES

8.1. The selected service provider will:

• Be technically and contractually accountable to the UNFPA Country Office for all aspects of the assignment;

- Be responsible to complete and abide by all local regulations and procedures for permission to produce 1.454 the panos;
- Deliver the tasks expressed in this TOR in close consultation and collaboration with the assigned officers from UNFPA and with District/Commune Farmers' Union Offices;
- Consult and agree with UNFPA on the detailed plan and obtain UNFPA approval when required;
- Brief UNFPA on the progress of activity implementation against the planned timeframe;
- Consult UNFPA to address challenges and problems arising during the consultancy assignment; and
- Be responsible for the quality of the activities, and final products.

8.2. UNFPA Country Office (CO) will:

- Develop a contract for signature between UNFPA and the selected service provider; and
- Facilitate the selected entity in completing its assignment, including problem solving as mentioned in the TOR:
- Provide comments on the products including detailed work plan, activities implementation plan, and final report before they are finalized;
- Monitor the progress and quality of the activity's implementation.

8.3. Vietnam Farmers' Union will:

- Provide the design of pano;
- The consent forms for using models' image in the communication products
- Direct District/Commune Farmers' Union to hang panos on the wall outside the People's Committee of communes and wards, and the Provincial Farmers' Union;
- Support UNFPA to monitor the progress and quality of the activity's implementation, including spot-check of pano installment.

11. QUALIFICATIONS

- Organizational capability (having a clear governing body and structure including organization chart and staff size for undertaking the consultancy work).
- Has appropriate management capacity including financial management system.
- Proven expertise and experience in conducting similar projects, preferably working with UNFPA and/or VFU. A list of past and current projects with similar scope and value will be an asset.
- Has experience working with multi/bilateral programmes/projects, development agencies in Viet Nam and UNFPA will be an asset.

12. PAYMENT TERM

A contract for professional services will be signed between UNFPA in Viet Nam and the selected company for the performance of the contract during the period from end of July to 30 September 2023. Full payment following the Contract of UNFPA General Terms and Conditions for contracts will be made upon submission of the request for payment with eligible invoice, the receipts of panos duly signed by District Farmers' Union authority, certified by UNFPA Programme Officer in charge, tentatively on 30 September 2023.
