UNFPA hereby solicits a quotation for the following service:

# PROFESSIONAL SERVICES TO CIRCULATE INFORMATION ABOUT SUPPORT SERVICES PROVIDED BY ANH DUONG HOUSE IN THANH HOA PROVINCE, VIET NAM

UNFPA requires the provision of professional services to circulate information about support services provided by Anh Duong House in Thanh Hoa province, Viet Nam.

This Request for Quotation is open to all legally-constituted companies that can provide the requested services and have legal capacity to perform in Viet Nam, or through an authorized representative.

#### III. Content of quotations

Quotations should be submitted in a single email whenever possible, depending on file size. Quotations must contain:

a) Technical proposal, in response to the requirements outlined in the TOR.

b) Price quotation, to be submitted with reference to the price quotation form.

Both parts of the quotation must be signed by the bidding company's relevant authority and submitted in PDF format.



### IV. Instructions for submission

Proposals should be prepared based on the guidelines set forth in Section III above, along with a properly filled out and signed price quotation form, and are to be sent by email to the UNFPA Viet Nam's secured email address <u>vbidtender@unfpa.org</u> no later than *Monday, 17 April 2023 at 10:00 AM Ha Noi Time*]<sup>1</sup>.

Please note the following guidelines for electronic submissions:

- The following reference must be included in the email subject line: **RFQ Nº UNFPA/VNM/RFQ/23/02 – [Company Name]**  Quotations, including both technical and financial proposals, that do not contain the correct email subject line may be overlooked by the procurement officer and therefore not considered.
- The total email size may not exceed **20 MB (including email body, encoded attachments and headers)**. Where the technical details are in large electronic files, it is recommended that these be sent separately before the deadline.
- Any quotation submitted will be regarded as an offer by the bidder and does not constitute or imply the acceptance of any quotation by UNFPA. UNFPA is under no obligation to award a contract to any bidder as a result of this RFQ.

## V. Award Criteria

In the event of a contract award, UNFPA shall award the Contract to the lowest priced Bidder whose bid has been determined to be most technically responsive with the bidding documents.

### VI. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of contract to increase or decrease by up to 20% the volume of services specified in this RFQ without any change in unit prices or other terms and conditions.

#### VII. Payment Terms

UNFPA payment terms are net 30 days upon receipt of invoice and delivery/acceptance of the milestone deliverables linked to payment as specified in the contract.

#### VIII. Fraud and Corruption

UNFPA is committed to preventing, identifying, and addressing all acts of fraud against UNFPA, as well as against third parties involved in UNFPA activities. Failure to fully cooperate with investigations will be considered sufficient grounds to allow UNFPA to repudiate and terminate the Agreement, and to debar and remove the supplier from UNFPA's list of registered suppliers.
