 - Quotations, including both technical and financial proposals, that do not contain the correct email subject line may be overlooked by the procurement officer and therefore not considered.
- The total email size may not exceed 20 MB (including email body, encoded attachments and headers).
 Where the technical details are in large electronic files, it is recommended that these be sent separately before the deadline.
- Any quotation submitted will be regarded as an offer by the bidder and does not
 constitute or imply the acceptance of any quotation by UNFPA. UNFPA is under no obligation to award a
 contract to any bidder as a result of this RFQ.

V. Award Criteria

In the event of a contract award, UNFPA shall award the Contract to the lowest priced Bidder whose bid has been determined to be most technically responsive with the bidding documents.

VI. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of contract to increase or decrease by up to 20% the volume of services specified in this RFQ without any change in unit prices or other terms and conditions.

VII. Payment Terms

UNFPA payment terms are net 30 days upon receipt of invoice and delivery/acceptance of the milestone deliverables linked to payment as specified in the contract.

VIII. Fraud and Corruption

ANNEX II - TERMS OF REFERENCE

FOR PROFESSIONAL SERVICE TO BROADCAST TVC ON VIETNAM FARMERS' UNION HOTLINE 18001768 SUPPORTING WOMEN AND GIRLS SUBJECT TO VIOLENCE

1. BACKGROUND

Violence against women (VAW) is a manifestation of a pervasive human rights violation and happens in all countries, including Viet Nam. According to the UNFPA-supported National study on VAW in 2019, about 62.9% of ever-married women aged 15-64 reported that they had experienced some form of violence at least once in their lifetime by their husbands or intimate partners, while 50% of them did not talk with anyone about their violence experience, and 90.4% of them never sought help from formal service providers or the authorities. Among all of the reasons that gender-based violence (GBV) survivors did not seek help is the lack of accessible supporting services.

In this context, the hotline – 1800 1768 has been established by the Vietnam Farmers' Union (VFU) on 15 December 2021 with technical support from UNFPA under the framework of the project entitled "Mitigating COVID-19 impacts on Vulnerable Populations – Ensuring National Progress to Achieve SDGs in Viet Nam," funded by the Government of Japan via UNFPA. After the project ended, the hotline has been maintained under the DFAT-funded project "Elimination of Violence against Women and Children 2021-2025".

Through the toll-free hotline 1800 1768, counselling and support as well as referral services are provided 24/7, meeting international standards to ensure the rights and safety of survivors of violence. The establishment of the hotline is significant as supplementary, timely and friendly assistance is available and accessible to survivors of violence, especially those living in the rural areas. Up to June 2023, the hotline received more than 12,600 calls and provided consultation and support to more than 1,400 women and girls suffering from gender-based and domestic violence, which highlight the high demand in supporting GBV survivors.

Among communication strategies to widely introduce the hotline 1800 1768, in 2021, VFU developed and broadcast the 30-second TVC on the National television VTV1 at the prime time. This helped the hotline and relating services reach out to numerous people, particularly women and girls experiencing and/or at risk of gender-based and domestic violence. In return, an increase in the number of call nationwide was demonstrated during the broadcasting period. During the 10-day broadcasting, 1.422 calls were received (in which 60% of callers knew the hotline via VTV1). In order to further increase the accessibility of supporting services provided by the hotline to wider public, it is crucial to continue circulating information about the hotline via mass communication. In this regard, the UNFPA Country Office wishes to engage an entity on a professional service contract to broadcast the video which introduces the hotline 1800 1768 on a national television channel.

2. PURPOSE/OBJECTIVES

The main objective of the professional service is to broadcast an available 30-second video clip on the hotline 1800 1768 right before the 7:00 PM News on the national television channel (preferably VTV1).

3. SCOPE AND FOCUS

• The video clip will be broadcast 01 time per day, right before the 7:00 PM VTV1 News The links of the video as follow:

• Implementing time: 2 weeks, tentatively from week 3 to week 4 of August, 2023

4. FINAL PRODUCTS/DELIVERABLES

An excerpt of TVC broadcast on the VTV1 was submitted by the contracted service provider as evidence of contract completion.

5. INTENDED USES & USERS

5.1 Intended uses:

- To disseminate information about available supporting services the hotline 1800 1768 free of charge;
- To raise awareness of public on GBV/domestic violence and call for actions to speak up and seek help.

5.2 Intended users:

• General population, especially women and girls who are experiencing and/or at risk of gender-based and domestic violence.

6. APPROACH AND METHODOLOGY

- The assignment will be conducted in a way that is gender and human-rights-responsive, inclusive, victim-centered approach;
- Interested service provider will submit a quotation for the services, a concrete implementation timeline including broadcasting schedule, and a plan for monitoring the actual broadcast.

8. ACCOUNTABILITIES

8.1. The selected service provider will:

- Be technically and contractually accountable to the UNFPA Country Office for all aspects of the assignment;
- Be responsible to complete and abide by all local regulations and procedures for permission to broadcast the video on the national television channel;
- Deliver the tasks expressed in this TOR in close consultation and collaboration with the assigned officers from UNFPA;
- Consult and agree with UNFPA on the detailed plan and obtain UNFPA approval when required;
- Brief UNFPA on the progress of activity implementation against the planned timeframe;
- Consult UNFPA to address challenges and problems arising during the consultancy assignment; and
- Be responsible for the quality of the activities, and final products.

8.2. UNFPA Country Office (CO) will:

- Develop a contract for signature between UNFPA and the selected service provider; and
- Facilitate the selected entity in completing its assignment, as mentioned in the TOR;
- Provide comments on the products including detailed work plan, activities implementation plan, and final report before they are finalized;
- Monitor the progress and quality of the activity's implementation, including the spotcheck of actual broadcasting work.

8.3. Vietnam Farmers' Union will:

- Provide the video clips to be broadcast;
- The consent forms for using models' image in the TVC;
- Support UNFPA to monitor the progress and quality of the activity's implementation, including the spot-check of actual broadcasting work.

11. QUALIFICATIONS

- Organizational capability (having a clear governing body and structure including organization chart and staff size for undertaking the consultancy work);
- Has appropriate management capacity including financial management system;
- Proven expertise and experience in conducting similar projects, preferably working with UNFPA and/or VFU. A list of past and current projects with similar scope and value will be an asset;
- Has experience working with multi/bilateral programmes/projects, development agencies in Viet Nam and UNFPA will be an asset.

12. PAYMENT TERM

A contract for professional services will be signed between UNFPA in Viet Nam and the selected company for the performance of the contract during the period of week 1 of August to 30 September, 2023. Full payment following the Contract of UNFPA General Terms and Conditions for contracts will be made upon submission of the request for payment with eligible invoice, the official acceptance of UNFPA and VFU for the excerpt of TVC on the TV, certified by UNFPA Programme Officer in charge, tentatively on 30 September, 2023.
