I. GENERAL BACKGROUND

Due to the Covid 19 pandemic, Vietnamese young international migrant wokers who returned from foreign countries meet to difficult of economic, psychological, lack of knowledge and skills professional care on SRH, GBV; lack of information and skills to seek help in training and replacement to integrate into community. To support Vietnamese young international migrant wokers who returned from foreign countries due to the Covid 19 pandemic, Government of Japan committed to sponsor the Government of Vietnam through the project "Support the Government of Vietnam in the development and monitoring of the implementation of national policies on the comprehensive youth development - VNM9P04 project" period 2017-2021 funded by UNFPA. One of the project's activities is counseling on psychological care and professional care on SRH, job training and replecement and life skills to integrate into family and community of Vietnamese young people working abroad who have to return home under the influence of Covid 19. Implementing this task, within the framework of the Project, The Central Centre for Youth and Adolescent recruits 04 Vietnamese domestic consulting experts support developing training material above. Materials be used to training persons who provider counseling service to support Vietnamese young international migrant wokers returnees due to the Covid 19.

II. PURPOSE
